## REGULATIONS

The Caisse Desjardins du Réseau de la santé (hereinafter "the Caisse") wishes to encourage all its current and future student members to pursue their studies in the health field. We are committed to providing them with financial support to help them achieve their career goals.

### ELIGIBILITY REQUIREMENTS

To be eligible for the Scholarships: « Coup de pouce santé » (hereinafter referred to as the "Program"), a student must meet the following criteria:

- Be a Canadian citizen or permanent resident;
  - Be a full-time or part-time student in professional, college or university training in a field that is related to health;
  - Be a full member of the Caisse Desjardins du Réseau de la santé upon registration and be 18 years of age or older as at the beginning of the Program;
  - Have your main residence in Quebec;
  - Agree to receive the deposit of the scholarship in the account of the winning member held at the Caisse Desjardins du Réseau de la santé;
  - Seminars or improvement workshops are not recognized.
1. The statement that, in all cases, the persons specified in Article 3 must be excluded at least;
  2. The following text: "Any litigation respecting the conduct or organization of a publicity contest may be submitted to the Régie des alcools, des courses et des jeux for a ruling. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement. »;
  3. The person for whom an advertising contest is held, his employee, his administrator, his representative, his agent or a member of the jury may not participate in this contest.

### HOW TO PARTICIPATE

To participate in the program, an eligible person must:

- Be a student during the summer and fall 2019 or winter, summer or fall 2020 semester at a post-secondary institution;
- Be a member of the Caisse;

- Complete the entry form available on the Caisse's website, youth section (desjardins.com/caissesante) and correctly answer the mathematical skill-testing question found there;
- Be able to provide a transcript or proof of payment of school fees upon request;

- The form must be received by the Caisse no later than **July 31, 2020 at 4 p.m**
- Limit of one participation per eligible person
- Submitting the application form will entitle you to one entry for the draw that will take place on August 7, 2020.

### **PRICES**

There will be ten (10) scholarships to be drawn on August 7, 2020 for a total value of 10 000 \$ :

- Professional training: two (2) scholarships of \$500 each to be won
  - College education: four (4) scholarships of \$750 each to be won
  - University education: four (4) scholarships of \$1,500 each to be won
- The amount of the scholarship will be deposited in the account of the winning member at the Caisse Desjardins du Réseau de la santé
  - The winning member agrees to take a photo and agrees that it may be used by the Caisse for marketing purposes.

### **DRAWING**

- The winners will be determined by a manual draw held on August 7, 2020 at the Caisse.
- The odds of winning depend on the number of eligible entries received during the entire duration of the Program.
- All coupons, following the draw, will then be retained in the event of disqualification(s).
- The amount of the scholarship will be deposited in the account held by the winner at the Caisse Desjardins du Réseau de la santé.

## **GENERAL TERMS AND CONDITIONS**

In order to be declared a winner, each selected person must:

Be contacted by telephone or e-mail by a Caisse advisor within thirty (30) days of the draw date;

Confirm that she is or was a student during the scholarship program enrolment period;

Agree to take a photo at the Caisse to mark the presentation of the cheque;

Sign the Declaration and Release Form (hereinafter referred to as the "Declaration Form").

Failure to comply with any of the conditions mentioned above or any other condition mentioned in these rules will result in the selected person being disqualified and a new draw for this scholarship will be held in accordance with these rules until an entrant is selected and declared a winner of this scholarship. The same conditions will continue to apply with the necessary adaptations, if necessary.

1. In the event that the selected person refuses to receive the prize, the Caisse will be released from any obligation to award the prize and may, at its discretion, conduct a new draw as described in this document.
2. Any person participating in the Program agrees to comply with these Regulations and the final decisions of the Fund administering the Program.
3. The Caisse reserves the right, at its discretion, to cancel, terminate, modify or suspend, in whole or in part, this Program in the event of an event or any human intervention that may alter or influence the administration, security, impartiality or operation of the Program as provided for in these Regulations. In such a case, no liability can be attributed to it.
4. In the event that, for any reason whatsoever, participation in the Program is terminated in whole or in part before the end date provided for in these rules, the draw may be made at the Caisse's discretion, from among the entries duly registered and received up to the date of the event that terminated participation in the Program.
5. In any case, the Caisse may not be required to award more prizes or to award a prize other than in accordance with these rules.
6. Prizes must be accepted as described in these rules and may not be exchanged, substituted for another prize or transferred to another person, except as provided in these rules.
7. Winners release the Caisse from any liability for damages that may result from its participation in the Program, acceptance and use of the prize.

The winners acknowledge that, as soon as they receive the call or email confirming their prize, the execution of the obligations related to the prize becomes the entire and exclusive responsibility of the various suppliers of products and services. The winners undertake to sign a declaration and release form to this effect and to take an official photo.

8. All registrations and declaration forms may be subject to verification by the Caisse. Those that are, as the case may be, incomplete, inaccurate, illegible, mechanically reproduced, mutilated, fraudulent, filed or transmitted late, with an invalid telephone number or otherwise non-compliant, may be rejected and will not be eligible for the prize.
9. The Caisse will not be responsible for lost, misdirected or late entries, including those due to a postal service problem.
10. The Caisse shall not assume any liability of any kind whatsoever in the event that its inability to act results from a situation or event beyond its control, a strike, a lockout or any other labour dispute in its facilities or those of the companies or organizations whose services are used to run the Program.
11. By accepting the prize, any winner authorizes the Caisse to use, if necessary, his/her name, photograph, image, voice and statement relating to the prize for advertising purposes, without any form of compensation.
12. The personal information collected about participants may be used for various communications that are not related to this Program.
13. Registration and declaration forms are the property of the Caisse and will not be returned to participants under any circumstances.
14. If a paragraph of these rules is declared or deemed illegal, unenforceable or invalid by a competent court, then that paragraph shall be considered invalid, but all other paragraphs that are not affected shall be applied within the limits permitted by law.
